USTelecom, AT&T, others ask full appeals court to overturn open internet rules

USTelecom and AT&T, along with other broadband and cable trade groups, on Friday requested a full-court review of a US appeals court decision that upheld the Federal Communications Commission's authority to issue open internet rules. USTelecom's petition argued that the three-judge appeals panel erred in allowing the FCC to bring the internet under its regulatory umbrella, that the FCC ignored congressional intent and that earlier court decisions were misinterpreted.
